KENTUCKY EARLY CARE AND EDUCATION CHILD CARE DIRECTOR'S CREDENTIAL

PROCESS

- 1. All candidate will be required to take the following courses:
 - EDU 568 Administration and Supervision in Early Care and Education Programs COURSE DESCRIPTION - Development of policies and procedures for administration and supervision in diverse early childhood programs (including family child care homes); identification of funding sources; inquiry into ethical behavior, regulations and laws; supervisory skills and staff development; interrelationship of philosophy/mission, program model design, and program evaluation.
 - ENTP 150 Overview of Accounting COURSE DESCRIPTION - Introduction to financial information generated by typical business organizations, with special emphasis on the use and interpretation of this information in managerial and financial decision-making processes by entrepreneurs.
- 2. For the third and fourth 3-credit hour courses, candidate will meet with the Director's Credential contact faculty for an individual evaluation and to identify two courses from list of potential courses (see table on page 2) based on individual candidate's background (i.e., experience, training, and education).
- 3. Candidate will sign the written contract of program. The written contract of program will be the table on page 2 with identified courses and candidate's signature/date.
- 4. When the candidate has completed all of the courses on the written contract of program, candidate will alert the Director's Credential contact faculty to schedule an exit interview time for the oral exam.
- 5. At the exit interview, one IECE faculty and one early care and education staff will ask open-ended questions about the seven competencies (explained on next page) to the candidate.
- 6. At the completion of exit interview, the candidate will be asked to leave the room so the two early care and education faculty and/or staff can reach a decision.
- 7. The candidate will be invited back for the reporting of the exit interview outcome.
