#### CALL FOR NOMINATIONS FOR AT LARGE SENATORS

#### Two Year Term: 1 July 2023 to 30 June 2025

Based upon the apportionment and the expiration of the terms of some of the current at-large college senators, the following vacancies need to be filled for the 1 July 2023 to 30 June 2025 term.

#### **Eligibility requirements: Faculty Senate Constitution:**

- full-time tenured / tenure track, or non-tenured track renewable faculty member
- faculty appointment for at least one year before assuming senate seat
- no more than 25% of time in an administrative appointment

Voting is restricted to full-time tenured / tenure-track and full-time renewable faculty of the nominee's college.

- At Large Senator Informatics 2 vacancies
- At-Large Senator Business 1 vacancy
- At-Large Steely Library 1 vacancy
- At-Large Senator Health & Human Services 2 vacancies
