Instructions for Section III (Parent Tax Information) and Section IV (Student Tax Information):

Tax Filers:

Important Note: The instructions below apply to each parent included in the household. Notify the financial aid office if the parents filed separate IRS income tax returns for 2022 or had a change in marital status after December 31, 2022.

Instructions: Complete this section if the parents/student filed or will file a 2022 IRS income tax return(s). As part of federal student aid eligibility, parents/student will be required to consent and approve sharing and importing income and tax information from the IRS to the FAFSA form, even if the attempt to obtain or use such data is ineffective. Get Transcript Online – Go to www.irs.gov, click "Get Your Tax Record." Click "Get Transcript Online." Make sure to request the "Return Transcript" and NOT the "Account Transcript." To use the Get Transcript Online tool, the user must have (1) access to a valid email address, (2) a text-enabled mobile phone (pay-as-you-go plans cannot be used) in the user's name, and (3) specific financial account numbers (such as a credit card number or an account number for a home mortgage or auto loan). The transcript displays online upon successful completion of the IRS's two-step authentication.

• Automated Telephone Request – 1-800-908-9946. Transcript is generally received within 10 business days from the IRS's receipt of the telephone request.

• Paper Request Form – IRS Form 4506T-EZ or IRS Form 4506-T. The transcript is generally received within 10 business days from the IRS's receipt of the paper request form.

Non-Tax Filers:

Non-tax filers **must provide** a confirmation of non-filing from the IRS dated on or after October 1, 2023. A confirmation of non-filing can be obtained from <u>www.IRS.gov/transcript</u> and click on "Get Transcript ONLINE" or by mailing in Form 4506-T and checking box 7.

Dependent students are <u>NOT</u> required to provide a confirmation of non-filing from the IRS if they did not file in 2022.
