Served as the campus CEO and oversaw all SCSU operations and its strategic direction. Responsible for managing \$210M operating budget; maintaining its 100 acres in St. Cloud, an offsite location in Plymouth, MN, and a global center in Alnwick Castle in Northumberland, UK. Represent SCSU at the state capital, in the business and civic communities, with the system chancellor, and with the Board of Trustees. Significant accomplishments:

- Successful Transition through Tragedy: Led the campus following former President Earl Potter's untimely death, including the important work of healing the campus and the community.
- **Strategic Planning**: Approved revision of 2017-2022 *Building the 21st Century Engaged University* strategic plan focusing on delivering student success, organizational sustainability, and strategic and reciprocal partnerships.
- Accreditation: Received reaffirmation of Higher Learning Commission reaccreditation through 2026-27.
- Enrollment Management & Student Success: SCSU signed an agreement with EAB for adoption of the Student Success Collaborative for a 5-year period to improve retention rates and assist at-risk students. Worked with Student Government and the system office to seek approval for a banded tuition model to incentivize credit-taking behavior for undergraduate students (15 to Finish campaign). Led implementation of aggressive strategic enrollment management plan targeting fall 2018 recruitment and retention.
- Awards and National Recognition: In 2017, SCSU received a National Science Foundation \$5 million Scholarships in STEM (S-STEM) grant to provide scholarships to students at SCSU and four partner community colleges; SCSU maintains the Carnegie Community Engagement classification through 2020. Other awards include Victory Media's Military Friendly designation (2016), Higher Education Excellence in Diversity (HEED) Award from INSIGHT Into Diversity magazine (5 straight years), and Forbes magazine's top 1% most affordable America's colleges (2016).
- Fundraising & SCSU's Sesquicentennial Planning: In 2017, raised over \$4 million in gifts, far exceeding annual target of \$3.5 million. Laid groundwork for SCSU's first comprehensive fundraising campaign in two decades. With VP for Advancement, recruited new community members to the SCSU Foundation board, engaged local and national alumni, and hosted numerous events to share SCSU's vision for the future.
- **Budgeting and Resource Allocation**: Help SCSU meet the conditions of its financial recovery plan by balancing its general fund budget for two consecutive years while adding \$4 million to reserves and setting aside \$1 million for strategic investments. In 2016, SCSU made structural and one-time reductions totaling \$8.7 million dollars through a consultative, transparent, and inclusive process.

- Diversity, Inclusion, & Internationalization: Help SCSU recruit students of color from the region as well as international students to build diversity on campus. With 1,500 international students from 85 countries and over 2,400 students of color, SCSU is one of most diverse campuses in Minnesota State. During my time at SCSU, seven administrators from diverse groups were hired, four of them to permanent positions. Developed and began implementation of SCSU's 2016-17 Diversity Plan focusing on recruitment, retention, and support for students of color, LGBT, veterans, low-income, women, and students with disabilities. Continued SCSU's long-standing commitment to comprehensive internationalization with renewed agreements with several international partners. In fall 2016, SCSU welcomed its 1st cohort of 70 students from Binhai College, Nankai University, China as part of a unique 2+2 program in finance.
- Community Engagement: Lead significant engagement with key community stakeholders including alumni, the mayor, local legislators, business and industry, and non-profit leaders. These activities resulted in securing funding of \$18.5 million to construct, renovate, and equip Eastman Hall for the relocation of consolidated student health services and academic programs. In addition, SCSU opened a new location in the Twin Cities suburb of Plymouth to offer professional graduate programs to working adults. With the help of a collaborative grant from Xcel Energy, began construction on a 500-gallon photo-bioreactor in a unique university-industry partnership focused on commercializing algae-based products.
- Strategic Partnerships: With an emphasis on developing and deepening reciprocal partnerships, engaged several key partners on defining the framework for such collaborations. Signed an agreement with St. Cloud Technical and Community College to better serve students, led conversations with CentraCare about workforce needs and research in healthcare, GeoComm on software application development, Chartwells/Compass on addressing student food insecurity, Learfield Communications on media rights, and the city of St. Cloud on issues such as environmental sustainability.
