(3) Calculate The test statistic & corresponding probability;


(4) Reach our conclusion; reject (or no) the null Ho.

Technically we would need to use a *t-table* to find probabilities associated with the t-distribution. Because the t-distribution is indexed by its degrees of freedom, it is impossible to have a single table of these probabilities. Instead of using a table to find probabilities, we'll rely on StatCrunch to calculate these probabilities.


Let's look at a couple of examples of p-values to refresh how the probabilities are found:

Example: Acetaminophen is an active ingredient found in hundreds of over-the-counter and prescription medicines, such as pain relievers, cough suppressants, and cold medications. It is safe and effective when used correctly, but there are consequences when too much or too little is taken. A researcher believes that the mean amount of acetaminophen per tablet in a particular brand of cold medicine differs from the claimed dosage of 600 mg. To investigate the claim, a random sample of 100 tablets is taken, and the average acetaminophen content was found to be 603.7 mg with a
